WHEN PICKING UP TREES, PLEASE BRING A TARP TO PROTECT YOUR TREES. ALL WRAPPING OF TREES WITH NURSERY MATERIALS WILL BE BILLED.

Orders

All verbal orders must be confirmed in writing. This eliminates unnecessary labor costs. A conformation of your order will be sent to you for your authorization. Upon return of your signed order, the material you wish to purchase will be dug.

Specimen trees personally selected and tagged may incur an additional charge of 15%. If any tagged materials are canceled or changed, the purchaser is liable to 10% of the unit costs for holding the stock.

Trees shipped to first time customers and customers with credit pending will be billed C.O.D.; this is to keep costs to both the customer and R & J Farms, Inc. at a minimum.

Freight

We encourage buyers to pick up their own stock. For those not equipped to do so, we can arrange delivery through a local freight company experienced in the handling of nursery materials. All costs incurred will be the responsibility of the purchaser.
